



A review of women's narrative in Shauna Singh Baldwin's fiction

This review paper examines how women narratives are presented in the fiction of Shauna Singh Baldwin in terms of narrative voice, structure, the use of language, imagery, and symbolism as well as the use of female centered characters. Shauna Singh Baldwin writes fiction that revolves around women and their experiences and voices, as the desire to tell stories is inherent to humans. Her works preempt the voices of women and how they can articulate their identities via narrative. Baldwin uses an array of narrative voices and structure to add depth and authenticity to her fiction. The paper will look at her storytelling techniques and how she creates women-focused stories, which will allow exploring their life in more social and cultural contexts.

Language is a tool of organization and presentation of ideas into cohesive forms. When these thoughts are molded into significant stories, they serve as a stimulus to the imagination of the writer as well as the readers. Narrative can be thought of as an organized description of events, or imagined events, in a specific order. The art of storytelling enables the author to express experiences in an artistic and interesting way that increases the involvement and meaning to the reader. According to Chris Baldick, the term narrative can be defined as the process of giving an account of events by a narrator and it is the choosing and organizing of events into a significant plot.

"A narrative can be defined as a description of events, factual or fictional, by a narrator or more than one narrator. Narration also known as discourse is the process of choosing and arranging events in a significant order, hence creating a plot. Narrative can be a short account of a simple event, a single sentence or a news item, or can be a more elaborate narrative, like a history, a biography, or a diary, or

a travelogue. Other genres found in fictional narratives are novels, epics, ballads and short stories. In literary criticism, there are generally first-person and third-person forms of narratives (Baldick, 2015)."

A story starts to emerge whenever one of the narrators wants to share experiences, ideas or emotions. Storytelling can be both oral and written, and a story can take different forms like prose, poetry, theatre, art or oral expression. Although there are these differences, all stories are composed of a series of events told by a narrator. Paul Hazel, in his essay Narrative: an introduction, postulates that a story is a form of reality, viewed through a certain perspective, which is organized in a manner that creates meaning and unity, as a single form of expression. To properly tell their stories, it is necessary to employ the right narrative techniques, which help writers to reshape the reality and introduce the depth and meaning to their work, making it an exciting artistic piece.

The story in question starts with the prologue, which is set in a North Indian context in 1895 and a sequence of events that follows in the timeline of certain time periods. The main storyline is the character Roop, which is set in 1928-1947, and the epilogue is set later in a city.

"Once again I am born a woman, naive girl child who has come into this world with her eyes wide open and would never lower them before a man..., Satya says in the epilogue, echoing the image of rebirth that opens the book. a corporeal memory... even if he called me a princess because my gurus advised him to, I will never be able to mature into a lady because males who do not embrace female infants will not be able to do the same. So much anguish and meaninglessness have I endured! While women have evolved, males have not (Baldwin, 2021)."

The novel's narrative is third-person, but the characters' inner monologues are first-person and prominently featured in the bold-to-italics transition.

Because the tale is not structured according to chronological time, the events are changed, and flashbacks are inserted throughout, the novel's storyline seems to be nonlinear. In

The Tiger Claw, the plot revolves on Kabir Khan's quest to find his sister Noor, which keeps the two time periods Noor's free life and her jailed existence close together until they combine.

The novel's rich vocabulary and lyrical prose are both enhanced by the abundant use of metaphor and simile. When used effectively, metaphors and similes allow the writer to demonstrate rather than describe, engaging the reader's imagination and evoking vivid mental images. Literary elements like metaphors and similes allow authors to give their work more depth. The word "metaphor" is defined in the Oxford English Dictionary as

One of the most common and significant figures of speech, it involves referring to one item, concept, or action using a term or phrase that usually denotes another, in order to imply that the two share some attribute. Rather of stating it outright, metaphor treats the similarity as an imagined identity.

"As an illustration, describing a person through comparison with another object or being reflects the use of figurative language (Baldick, 2015)."

Metaphors are not a minor aspect of the writing by Baldwin, as they add splendor to his story, serving as images and symbols. Indicatively, one of the characters describes herself as a flowing river, and employs this picture to illustrate movement, life and continuity. Such metaphorical device emphasizes change and emotionality, which enables the readers to connect more with the inner world of the character (Baldwin, 2012)^[4].

There is also heavy use of similes and metaphors in the text, and they add to its expressive nature. A simile is a direct comparison of two different things, most commonly with the help of such words as as and like. It is a common literary technique in poetry and prose to produce clarity and beauty, more often than metaphor is done in a decorative way (Baldick, 2015).

Throughout her work, Baldwin uses a rich combination of multilingual words and culturally infused phrases. Certainly, words and phrases are regularly italicized in order to underline their contextual meaning and to maintain their cultural peculiarity. Such vernacular phrases and colloquialism add to the authenticity of the story and also add to the style of the story.

What the Body Remembers is a narrative that explores the life of Roop and Satya but goes beyond personal relationships and delves into the societal changes in the society. The text functions as a metaphor of a historical transition, and the processes of interpersonal relationships are used to represent the greater divisions in the society. The correlation between the protagonists is a symbol of opposing sides of identity and the image of Sardarji can be viewed as a symbol of domination and power. These stories frequently touch on the inner world of women showing their emotionality and sensitivity towards social limitations. The characters are resilient because they are able to negotiate institutionalized societal demands and to attempt to establish their uniqueness. By depicting them this way, Baldwin prefigures the voices of women and introduces them as actors who can determine their lives. The narratives are set in a variety of locations, both rural and urban and on a larger transnational scale. This space movement is an indication of the changing identities and experiences, which enable characters to interact with new environments and worldviews.

The character is not focused on outward action but rather on the inner growth, where Baldwin focuses on minor, but significant, personality and growth. In these stories, there are those characters who adhere to the traditional values, and there are those who do not conform to the established norms and explore other ways. This opposition is the dynamic tension between continuity and change. Male characters are frequently used in supporting roles either to

support or mirror current social structure and the main focus is on women. The involvement in the issues of identity, culture, and social change has been largely identified in the contributions of women writers in the modern literature.

These authors present various views that oppose the traditional norms and broaden the horizons of the literary discourse. Migration, cultural contact, and the reconstruction of tradition is a frequent theme in their work, and they focus on the subjectivity of individuals and the expression of themselves. In this regard, the writing of Baldwin can be considered as a part of the wider literary trend that attempts to redefine the traditional discourse and challenge the mainstream models.
